



TERMS AND CONDITIONS

You agree to hire the eBike and accessories (together "equipment"), to pay the cost of Hire and you accept the terms on this form.

You accept complete responsibility during the period of hire and for the safe custody of the equipment and for any loss, theft or damage (howsoever caused). You are responsible for the security of the bicycle and must lock it to a fixed object whenever unattended and keep the equipment safeguarded at all times. You must return the equipment at the specified time and date. Any loss, theft, damage or accident should be notified to the us immediately and in the case of theft or accident to the nearest police station too. Please retain a copy of this form for identification purposes.

A damage deposit is required before hire the hire of equipment commences and shall be in the form of an open credit card voucher. This will be destroyed upon return of the equipment subject to the following terms. The deposit is to be held against any loss, theft, damage or failure to return the equipment by the specified time and date. If not returned by the specified time and date, the cost of hire shall be charged on a pro rata basis until it is returned. Any late return, replacement or repair costs or insurance excess payments may be deducted from the deposit. You shall pay any such costs in excess of the deposit.

You accept that cycling has risks and confirm that you are a competent cyclist. You should not ride if you are in ill health, have a disability likely to affect ability to cycle, or your eyesight is not up to the standard required by a road driving test. Do not ride under the influence of alcohol, strong medication or other drugs. It is strongly advised that you wear the helmet and use other appropriate safety equipment provided with your eBike. Front and rear lights are required in hours of reduced light.

Please follow the Highway Code. Do not ride on pavements, against traffic, or more than two abreast. Do not run red lights. Be courteous to Pedestrians and other road users. Ride responsibly: do not attempt any maneuvers beyond your skill level or the eBikes specific capabilities. Our eBikes must not be submerged in water. They can be ridden in the rain however deep puddles should be avoided.

You accept full responsibility if you ignore any of the above and we are not liable for death or injury to any persons or loss or damage to any property that results. Save in respect of liability for personal injury of death resulting from our negligence, Ullswater eBikes liability to you whether in contract, tort (including negligence), breach of statutory duty or otherwise is limited to the cost of hire. You agree to indemnify us against any liabilities, costs, expenses, damages and losses arising out of or in connection with the death or injury to any person or any damage to property resulting from your hire or use of the equipment. We advise that you do not ride without personal and third-party liability insurances.

In signing our terms and conditions, you are agreeing to the following,

I am 18 years old or older and I will undertake the hire activities in accordance with the Terms & Conditions written above, together with any other oral instructions or advice given to me before commencing the hire activities. I understand the Activities will take place in a potentially dangerous environment. I accept that there is a risk of injury whilst undertaking the Activities. I certify that to the best of my knowledge, I or members of my party do not have a medical condition which might have an effect of making it more likely that I be involved in an incident which could result in injury to myself or others.

We reserve the right to cancel any hire at any time should we deem it necessary for reasons of safety.
